Annual Dinner

The 2002 AACRL dinner and business meeting will be held on Wednesday, April 10, at the Wild-Flour Bistro, located at the corner of Holmes and Jordan Lane in Huntsville, close to the UAH campus. This is a locally owned and operated restaurant with outstanding food. To quote (excerpts) from a Huntsville Times restaurant review: "Sometimes you can go to a restaurant expecting to be impressed. And sometimes you can be disappointed. Not so at WildFlour bistro. Go expecting the best, and you're not likely to be wrong. The bistro blends a formal-yet-casual ambience. The speaker at the annual dinner will be 2001-2002 ACRL President. Mary Reichel, University Librarian and Carol Grotnes Belk Distinguished Professor at Appalachian State University (Boone, NC). Dr. Reichel has been an active member of ALA and ACRL since 1977. She has served on the ACRL Board and has chaired the Instruction Section. the Appointments and Nominations Committee and the President's Program Planning Committee. She also has served on the Southeastern Library Network (SOLINET) Board.

Prior to going to Appalachian State University in 1992, Dr. Reichel held positions at the University of Arizona (Tucson), Georgia State University (Atlanta), the State University of New York at Buffalo and the University of Nebraska at Omaha. She holds a Ph.D. in Higher Education from Georgia State University, an M.A. in Library Science from the University of Denver, and a B.A. in History from Grinnell College.

Dr. Reichel was awarded the Miriam Dudley Instruction Librarian Award from the Instruction Section of ACRL in 1999. Her ACRL Presidential theme is "ACRL: the Learning Community for Excellence in Academic Libraries." Her topic for our program will be "Scholarly Communication: Academic Libraries and the Web."

Active Learning Workshop

Samford University Library hosted the AACRL / CUS workshop, "Active Learning as a Pedagogical Approach for Information Literacy" on January 23.

The 2002 Miriam Dudley Instruction Librarian of the Year, Randy Hensley, who hails from the University of Hawaii at Manoa, led the workshop, teaching new approaches to library instruction and inspiring creativity in the library classroom. Randy challenged us to think of teaching in a new light. He demonstrated effective active learning by having us draw on our own positive personal experience with active learning. In the same way, by engaging a student's personal experience, you can capture their interest and then use active learning to teach them information literacy. Beyond teaching, we learned ways for students to practice what was taught and how to evaluate if the students learned the objective. Participants evaluated their own instruction approaches, identified weaknesses, and developed changes in their approach. As small groups, we designed an instructional session that incorporated active learning and presented it to all participants. Collaboration is another part of the active learning process, so observers critiqued each group's design. Randy's charismatic presentation led us to use our own creativity to reach our library patrons through active learning.

ABA Finds Problems with UCITA

As some of you may have heard, the American Bar Association has recently announced their grave misgivings about the Uniform Computer Information Transaction Act, better knows as UCITA.

In an article on the *ComputerWorld* web site (http://www.computerworld.com), it's reported that the ABA has found UCITA to be "extremely difficult to understand" and opponents of UCITA are seeing this latest report by the ABA as some of their strongest support to date – "This report validates the beliefs of the opposition that UCITA is still unworkable in its current form."

The need for a uniform law on licensing isn't at question by the ABA report, rather it's the current law as stated in UCITA that is the problem. The ABA committee that was charged with this latest review stated they found UCITA to be "a very complex statute that is daunting for even knowledgeable lawyers to understand and apply." As expected, supporters of UCITA disagree.

UCITA has been adopted in two states: Maryland and Virginia. Attempts have been made to adopt the law in other states, but have thus far failed. It has been recognized by one member of the ABA review committee that " ... the ABA opposition will make passage of the law by other state legislatures impossible."

Miriam Nisbet, who serves as legislative counsel for ALA is quoted as stating that the ABA statement is a "'pretty good assessment' of UCITA's possible fate."

News from the Membership

Dr. Stella Bentley, Dean, Auburn University Libraries, has accepted an appointment as Dean of Libraries, University of Kansas.

Delores Carlito, Reference Librarian, Sterne Library, University of Alabama at Birmingham, was appointed by the Network of Alabama Academic Libraries to edit a new version of its out-of-print Collection Assessment Manual (ED 290-462). Ms. Carlito will work with NAAL collection development and electronic resources librarians to update the manual with a special emphasis on incorporating electronic resources in a collection assessment.

Thanks to a grant from the J.L. Bedsole Foundation written by Amy Prendergast, Kathy Jones, and Jim Norman, the University of South Alabama University Library can now provide adaptive technologies to assist disabled library users to do research requiring internet access. Tiffany Harris, University Library Management Systems Specialist, and her assistant, William Weaver, set up the system.

The workstation has Dragon Naturally Speaking voice recognition software, a touch screen monitor, Zoomtext text enlargement and screen reader and Open Book print text reader software, a scanner, large key keyboard, and a track-ball mouse. It is available to students, faculty, and members of the community.

Mary Reichel, ACRL president, will speak at a luncheon sponsored by the College, University and Special Libraries Division of ALLA at the annual convention in Huntsville. Her topic will be "Academic Libraries as Learning Communities."

Tax-Exempt Status Assured; Incorporation Complete

On November 9, 2001 an employee of the Alabama Department of Revenue sent AACRL Past-President Tim Dodge an e-mail message stating, "You are automatically exempt if you are exempt for Federal." Since the Internal Revenue Service had officially recognized AACRL as a taxexempt Section 501 (c) (6) organization on September 17, the lengthy process of incorporation was now complete.

For a more detailed history of the incorporation of AACRL, I suggest readers consult issues of the Newsletter from 1998 onward. I will briefly summarize key events here. Several years ago the (national) ACRL decided to require all 42 state and regional chapters to either merge with their state library association or incorporate separately. The reason for this was ultimately to protect ACRL from any potential lawsuits incurred by a state or regional chapter. Starting in 1998, AACRL Past-President Katy Ginanni and President Craig Beard began to investigate the issue and survey the membership as to which course of action should be taken. The membership attending the April 1999 annual business meeting voted in favor of incorporation and thus remaining an independent association not affiliated with the Alabama Library Association.

Later that year, the membership was solicited to vote again on incorporation because it was determined that the AACRL Executive Board had no real authority to offer affiliation (i. e., merging) with the Alabama Library Association and that the Alabama Library Association's CUS (College, University, and Special Libraries) division more or less made another similar division redundant. The membership was now given the choice of voting for the incorporation or the dissolution of AACRL. The vote was for incorporation. At this stage, Past-President Craig Beard formed a committee to investigate the actual process of incorporation.

With the deadline of December 31, 2000 set by the national ACRL, the process of incorporation coincided with the term of AACRL President Tim Dodge. This task was accomplished with the aid of a committee and

AACRL met the national deadline by being incorporated as a non-profit organization with the State of Alabama on October 23, 2000. Again, with the aid of a committee, Past-President Tim Dodge was able to register AACRL as a tax-exempt organization, first with the IRS (September 17, 2001) and then with the Alabama Department of Revenue (November 9, 2001).

The above account is a simplified version of the events. The names of many helpful committee members and others in AACRL who assisted with this process have not been listed here but I would like to thank them all. Just a few of the people who deserve special thanks include Past-Presidents Katy Ginanni, Craig Beard, and Pat Henderson; President Jean Thomason, and Past-Treasurer Susan Herring. While my name has been prominently associated with the incorporation of AACRL over the past couple of years, I would not have been able to do all of this work on my own. I am glad it is over.
