From the President ...

THINKING LIKE OUR STUDENTS I've been working this week to clean off my desk and clear out some files. We've just migrated from Dynix to Horizon – without the benefit of a systems administrator – so I'm clutching at straws to restore some sense of order to my days. I came across my notes from last year's ALA conference in Toronto and found the scribbled phrase "thinking like our students." This phrase brought to mind a recent discussion I had with another librarian as we wrestled with Horizon to find out why we seem to have lost our "see" and "see also" references.

Using lists from the old system, we started comparing hits using subject and keyword searches. When we got to "Acquired immunodeficiency syndrome," I realized that no user would be likely to enter this phrase instead of "AIDS." It made me wonder if finding the missing "see" and "see also" references was so important now that library systems do a good job with keyword searching. 'Lest I get email from catalogers, I do know that precision is affected and that records for older titles may not reflect the current popularity of the abbreviation "AIDS." But, the bottom line is that library users are not interested in searching: they're interested in finding.

As academic librarians, we need to keep in touch with our users and, as part of a "graying" profession, we probably need to be reminded occasionally to "think like our students." One way I try to keep in touch is to read Beloit College's "Mind Set List," currently available for the Class of 2007 at http://www.universities.com/Schools/B/www.Beloit_College.asp. I get a better perspective when I'm reminded that, in addition to being congenitally addicted to cell phones, today's college and university students have always had unleaded gas, have always used stores with scanners at check-out, and have always had Lean Cuisine.

Another source on "thinking like our students" is "Our Incoming Students: What Are They Like?" by Linda J. Sax in *About Campus* (Jul 2003, pp15-21), which is available via the AVL. On the ACRL web site, you can find the "OCLC White Paper on the Information Habits of College Students: How Academic Librarians Can Influence Students' Web-Based Information Choices" (June 2002).

Speaking of order and influence, I am pleased to be working this year with these AACRL officers and board members: Jennifer Long, Vice President/President-Elect; Carla Waddell, Secretary; Kate Ragsdale, Treasurer; Rosemary Arneson, Member-at-Large/ACRL Chapter Liaison; Eric Kidwell, Legislative Liaison; Della Darby, Newsletter Editor; and Beth Ashmore, Webmaster.

We will also have the benefit of the wisdom of Past President Patty Pilkerton to help us through the year. Some of you will be hearing from her soon as she begins the process of recruiting officers for the 2005-2006 nominations. I am also recruiting volunteers to serve on a By-Laws Review Committee for the year. We need a review of the current by-laws to check for errors and to propose changes and updates, including the addition of the Legislative Liaison and Webmaster as official members of the Executive Board. National Library Legislative Day

Although I have been to Washington many times, this was my first visit as a lobbyist. The city never fails to impress me. With this trip, I got a real "behind the scenes" look at how Washington runs.

National Library Legislative Day began with a pre-conference on Sunday to introduce those of us who had never lobbied before to lobbying methods. We were told, when talking to our senators and representatives and their aides, to emphasize what our libraries need and how they fit into our communities. **Emily** Sheketoff, Associate Executive Director of the American Library Association managing the Washington Office (ALA WO), gave us the five "p"s of lobbying: Prior Planning Prevents Poor Performance. She also suggested inviting those in Washington to events at our libraries and emphasizing why we are crucial for the community. She suggested using examples of how local libraries have helped their communities in our talks.

Monday was the Briefing Day, or the day when we would hear about issues on which ALA was specifically working. The day was a full day of issue briefings that informed and prepared us for the congressional visits. It began with a "Fast Track Summary" that briefly introduced us to hot issues and key messages for congress. After that, we broke into plenary sessions. I attended the session on surveillance, privacy, and the Patriot Act. Speakers at that session were Joseph Zogby, Senator Richard Durbin, and Brooke Roberts. I later went to the session on Copyright which featured Jonathan Band, a lawyer at Morrison & Foerster. Key issues brought up during these sessions were:

- Supporting the Security and Freedom Ensured (or SAFE), Act (S 1709 and HR 3352)
- Supporting the Freedom to Read Protection Act (HR 1157)
- Supporting the Digital Media Consumers' Rights Act of 2003 (HR 107)
- Supporting the Consumers, Schools, and Libraries Digital Rights Manage-

- ment Awareness Act of 2003 (S 1621)
- Supporting the Benefit Authors without Limiting Advancement or Net Consumer Expectation Act of 2003 (HR 1066)
- Not supporting the Database and Collections of Information Misappropriation Act (HR 3261), and instead supporting the Consumer Access to Information Act of 2004 (HR 3872)
- Not supporting the Anti-Terrorism Intelligence Tools Improvement Act of 2003 (HR 3179)
- Continuing funding of the Library Services and Technology Act (LSTA)
- Funding the Improving Literacy Through School Libraries Program

Between sessions we had lunch. I attended the Association of College and Research Libraries Legislative Luncheon. Emily Sheketoff and Mark Smith spoke on "Effective Strategies for Your Capitol Hill Visit." ACRL issues at this year's National Library Legislative Day were anticircumvention technologies, database protection, digital rights management, broadcast flags, distance education, and public domain legislation. ACRL supported funding for the LSTA, the Federal Depository Library Program and the GPO, Library of Congress, the National Agricultural Library, and the National Library of Medicine. ACRL also promoted access to government information and amending the USA PATRIOT Act.

The following day, Tuesday, was the actual Legislative Day. Rebecca Mitchell, Director of the Alabama Public Library Service (APLS), had set up appointments for us with Alabama senators and representatives. In addition to Ms. Mitchell, Derrick Mitchell and Cutter Hughes were also part of the Alabama delegation, representing public advocacy of libraries. Mitchell and I presented a united front, with both of us thanking everyone for E-rate and LSTA while emphasizing the importance of the Alabama Virtual Library to all communities in Alabama. We first met with a representative for Congressman Robert Adherholt, followed by those for Congressman Jo Bonner, Congressman Spencer Bachus, Congressman Mike Rogers, Congressman Artur Davis, and Senator Jeff Sessions. When we arrived at Senator Richard Shelby's office, we were pleased to be able to meet directly with Senator Shelby, who was very concerned with education and libraries in Alabama. We then met with a representative from Congressman Terry Everett's office before meeting with Congressman Robert E. "Bud" Cramer.



As the representative for Alabama academic libraries, I thanked Bachus for cosponsoring the Digital Media Consumers' Rights Act of 2003 (HR 107) which attempts to restore the balance between fair use and copyright in the digital environment and allows libraries to circumvent technology for non-infringing uses, such as preservation and changes for the vision-impaired. I asked the other members of the house to sponsor HR 107. I also asked everyone to sponsor HR 2601, the Public Domain Enhancement Act, which allows abandoned works to go into the public domain more easily. Ms. Mitchell and I emphasized the relationship between all libraries and all students and communities in Alabama and how continuing funding and voting for bills that will allow works to go into the public domain more quickly will help those in Alabama, especially those in poorer and underserved areas.

The day was even more exciting than I thought it would be. After five and one-half hours of walking and talking, my feet were sore and my voice was hoarse. Unfortunately, I did not stay for the reception that evening. The ALA Washington Office

The ACRL Chapters Council met on Sunday, June 27, 2004 during the ALA Annual Conference in Orlando, Florida. Elections were held for the officer positions of Vice-Chair and Secretary. Camila Alire, ACRL President-Elect, reported on planning for the ACRL National Conference to be held April 7-10, 2005 in Minneapolis, Minnesota. The theme of the conference is "Currents and Convergence: Navigating the Rivers of Change" and the keynote speakers are William J. Mitchell from MIT and Sylvia Hurtado from the University of Michigan. ACRL members planning to attend are encouraged to volunteer to assist with preconferences, meeting rooms, and the Internet Cafe. Frances Maloy, ACRL President, reported on the ACRL Strategic Plan which was adopted by the ACRL Executive Board during the conference. She spoke about ACRL's core purpose (leading academic and research librarians and libraries in advancing learning and scholarship) and values (visionary leadership that is receptive to change, commitment to member services, integrity and transparency, diversity, continuous learning, and dedication to the values of higher education, intellectual freedom, and the Library Bill of Rights). She also spoke about the big audacious goal which is the need for academic and research librarians and libraries to be seen as indispensable in advancing learning and scholarship. She outlined the main strategic areas of the plan (higher education and research, the profession, the association, and sustainability) and identified the goals and objectives in each area. Mary Ellen Davis, ACRL Executive Director, reported on some of the topics discussed at the Executive Board meeting. News From the Membership

Della Darby, Lori Northrup, Carla Waddell, and Heather Watters, Samford University, had their article, "Cooperation in a Multi-Faceted Reference Department: Blending Resources, Personnel, and Services of Reference, Instruction, Interlibrary Loan, and Government Documents" published simultaneously in The Reference Librarian (no. 83/84) and as Cooperative Reference: Social Interaction in the Workplace, Haworth, 2003.

John-Bauer Graham, Library Instruction Coordinator, Jacksonville State University, has been invited to join the Board of *Journal of Academic Librarianship*. His term will officially begin January 1, 2005 but he will begin reviewing papers in August.

Dr. Mike Malone, executive director of the Alabama Commission on Higher Education, appointed Mrs. Sherida Downer, director of university libraries at Auburn University, to represent ACHE on the Alabama Virtual Library Council. She replaces Dr. Jerry Stephens, whose term expires on September 30. She joins Dr. Janice Franklin, Alabama State University, and Dr. Paul Mohr, ACHE, to represent higher education.

Dr. Paul Mohr, ACHE, has been elected chairman of the AVL Council beginning 1 October.

Patty A. Pilkerton, University of Alabama at Birmingham, visited Cuba July 1-10 as a Global Exchange Consultant. The group of six librarians (three from Alabama, and three from California) visited libraries to learn about the current state of the library system in Cuba.

"We visited Biblioteca Nacional Jose Marti -- the National Library of Cuba -- in Havana and met with the director and key staff members. We learned about the history of the library itself; the National Reading Program in Cuba, begun in 1998; the cultural mission of all Cuban libraries; the image of librarians as professionals;

ASCUBI (La Asociación Cubana de Bibliotecarios), the Cuban Librarian's Association; and other library issues, such as collection development, technology, patron services and usage, and budgets.

"The group also visited Biblioteca Ruben Martinez Villena - the public library in Old Havana City; the National Library of Science and Technology (IDICT) - a department of the Institute of Science (Academia de Ciencas de Cuba): the School of Communication. Journalism and Library Sciences at the University of Havana; the Museum of Literacy (Museo Nacional de la Campana de Alfabetizacion); the UNESCO Document Center; the National School of Library Technicians: Biblioteca Publica Ramon Guiteras - the Provincial Library in Matanzas Province; Biblioteca Antonio Maceo - the Municipal Library in Bauta, Cuba; Museo Nacional de Bellas Artes - the National Art Museum; and the Library at the University of Havana.

"At each library we met with directors and key staff, and came away with a much greater understanding of the issues and challenges facing the libraries in Cuba as they move into the 21st century."

Dr. Bob Schrimsher, Pharmacy Librarian and Associate Professor of Pharmacy Practice, Samford University presented a poster on the *International Journal of Pharmacy Education*, of which he is the editor, in Seoul, Korea at the 4th Asian Conference on Clinical Pharmacy, July, 24-26, 2004. He also gave a presentation on "Writing for Publications: Helpful Hints for Publishing Scientific Articles."

Alabama A&M University has appointed **Dr. Clarence Toomer** as its library director. Dr. Toomer will come to Alabama in August from the position of Dean of Library and Learning Services, Livingstone College in Salisbury, North Carolina. He has B.A. in Sociology (Livingstone College); M.L.S. (North Carolina Central Univer-

sity School of Library and Information Sciences); and an Ed.D in Adult and Higher Education (North Carolina State University at Raleigh).

Dr. G. Garry Warren, director of information technologies for the University of North Alabama, has been named Interim President of the University.

University Libraries at The University of Alabama, in partnership with the UA School of Library and Information Studies (SLIS), has been awarded a \$449,201 grant from the Institute of Library and Museum Services (IMLS) under the program Recruiting and Educating Librarians for the 21st Century. Funding will cover tuition for ten students who have completed a graduate degree in another subject to study academic or research librarianship through the SLIS program. The grant also covers a stipend for these students who will work 20 hours per week each semester in University Libraries. Practical training and classroom theory will be combined with a mentoring experience to prepare students in the program for a career in academic or research librarianship. The purpose of the 26 grants awarded by IMLS under this program is to recruit and educate new librarians to help to offset a national shortage of library professionals.
