The bylaws changes will be presented for approval to the membership attending the annual meeting.

In November, Legislative Liaison Eric A. Kidwell alerted me to the fact that the Southern Association of Colleges and Schools (SACS) was planning on dropping the criteria concerning libraries and librarians from their accreditation standards. Eric quickly drafted a letter that I then lightly edited and sent out in my name on behalf of the AACRL Executive Board to SACS expressing our concern.

I am happy to say that our letter plus those of 134 other concerned persons has persuaded SACS to include at least some mention of libraries and librarians in their accreditation standards. However, this issue will require monitoring in the future.

Member-at-Large Michael Grace has been making efforts to recruit new members and to keep the AACRL institutional liaison network going. If your membership is expiring soon, please RENEW! If you would like to serve as the AACRL liaison for your library, please contact Mike.



ACRL Chapter Relations Council Meeting

The ACRL Chapter Relations Council Meeting took place as scheduled on January 14 as part of the American Library Association Midwinter Conference in Washington, D.C. this year. Council Chair Evelyn Minick opened the meeting with a brief review of the purpose of the Council and stressed that this was the only real way for ACRL officers and state affiliates to meet to share ideas, news, etc. Approximately 25 to 30 representatives of the 42 affiliates were in attendance.

Vice Chair Linda Kopecky announced that she was still soliciting nominations for the positions of Vice Chair, Secretary, and ACRL Director-at-Large for 2001-2002 membership year. (Note: I had already contacted Kopecky in December 2000 to express my interest in the position of Secretary. Elections will take place at the next Council meeting in June in San Francisco).

Secretary Sherri Edwards passed out copies of the minutes of the July 9, 2000 meeting held in Chicago. The minutes were approved.

ACRL Member Services Coordinator Melissa Cast promoted the forthcoming national conference that will take place in Denver in March. ACRL's information literacy standards are now in their fourth printing. February 2 was promoted as Job Shadow Day: librarians are encouraged to invite students of junior high and high school age to observe them at work. It is hoped this will be one way of recruiting future librarians. Cast also mentioned the forthcoming New Member Mentoring Program.

ACRL President Betsy Wilson addressed the Chapter Relations Council next. She also promoted the national conference that will take place in Den-Wilson announced that Past-President Larry Hardesty has agreed to serve as chair of the committee that will organize the 2003 national ACRL conference that will take place in Charlotte, N.C. Wilson also reported on the recent ACRL Member Results indicate that Survey. members value professional development and publications supplied by the ACRL. Finally, Wilson announced plans for making available scholarships so that persons currently enrolled in library school or new to the profession can attend national ACRL conferences.

ACRL President-Elect Mary Reichel said that her priorities for the coming year include following the ACRL Strategic Plan. The theme for ACRL currently is "ACRL - Learning Community for Excellence and Academic Libraries." She encouraged Council representatives to recruit new members. Reichel also plans to promote information literacy and to encourage library leaders to confront the new realities of the information age.

ACRL Member Services Melissa Cast reported on the incorporation status of state affiliates. The Georgia chapter has merged with the Georgia state library association, the Western Pennsylvania/West Virginia chapter is in the process of incorporating, and there was no news concerning the Arkansas In response to the chapter.

ACRL directive of 1997, 11 state chapters have incorporated as non-profit organizations and 14 have merged with state library associations. As the Alabama representative, I was proud to announce the incorporation of the AACRL as a non-profit corporation on October 23, 2000. Unfortunately, no one at the meeting could supply me with helpful information concerning our new income tax obligations.

Next to address the council was Lynn Bradley, Director of Government Relations at the American Library Association's Washington, D.C. Office. major issue facing librarians now is the Uniform Computer Infor-Transactions mation (UCITA). Bradley asked for help from academic librarians. example, we could supply information and case history examples of situations where UCITA would or could seriously harm the free flow and use of information for scholarly/educational purposes. Call 1-800-941-8478 for more information on UCITA, copyright issues, and copyright educational programs. Already, versions of UCITA have become law in Maryland and Virginia. UCITA is also under consideration in the legislatures of Delaware, Hawaii, Illinois, and Iowa.

ACRL Executive Director Althea Jenkins announced that the Library Services and Technology Act (LSTA) of 1996 will be up for reauthorization with the new Congress and needs to be strengthened. The act needs to become more inclusive in scope and federal funding, ideally, should be increased from \$150,000,000,000 to \$500,000,000.

Jenkins encouraged librarians to contact their Congresspeople to support the reauthorization.

Ms. Pat Walker, ACRL Chapter Relations Council Legislative Network Coordinator, said that all 42 chapters have a Legislative Liaison in place (Eric A. Kidwell serves in this capacity for Alabama). Walker said academic librarians are still underrepresented at ALA Legislative Day in Washington, D.C. each year. For 2001, Legislative Day will take place on two days, April 30 - May 1.

The meeting ended with an interesting Power Point presentation by Mr. Merrill Stein and Susan Ottignon of Villanova University (Florida): "ACRL Review of Chapter Web Sites." They reported that 22 chapters out of a total of 42 have a functioning web site. The web sites were evaluated by criteria including content and design. Highlights included the Delaware Valley Chapter's, the Louisiana Chapter's ("simple yet elegant") and the Texas Library Association's ("clear identification of affilia-Stein and Ottignon reviewed some suggested "best practices" and stressed that a chapter's web site serves as an electronic calling card.
