From the President ...

Best Practices – that's the theme of the last few programs we have co-sponsored with CUS at the Alabama Library Association annual conference. We're doing that again with good reason: we all like to see what's going on at other institutions and adapt good ideas to our own practices. Della Darby, who chaired this project for AACRL, has made some excellent selections for 2005.

Called "Effective Practices," we can also find examples on the ACRL website at www.ala.org/ala/acrl/acrlissues/effectiveprac/effectivepractices.htm. For example, the Information Literacy Team at the University of Maryland libraries has developed a list of what to do before, during, after, and outside of library instruction classes. Another effective practice is a program entitled "Book of the Quarter," sponsored by the Michel Orradre Library at Santa Clara University (CA). The library invites a segment of the University community to select a book that will be the topic of a conversation that is held in the Library. Selections have included controversial topics, bestsellers, and both academic and non-academic titles (beginning with a selection by their athletic program). These are only two of the twelve "effective practices" included on the ACRL website at present.

ACRL applies several criteria in selecting effective practices for its website. First, the practice must be aligned with the library mission and articulated in its strategic plan. To be considered effective, the practice must have measurable outcomes. It must also be sustainable, cost-effective, and capable of long-term impact on the library and its constituents. The practice must have components that are transferable, that is, potentially useful within other contexts. Finally, the practice must be responsive, or articulated in terms of responding to the needs of academic libraries and their constituencies.

We know that Alabama's college and university libraries also have effective practices. Share your successes by contributing an effective practice to ACRL. The online submission process makes it easy to share your ideas with others. Please show ACRL what Alabama's college and university libraries have to offer!

As a final "good" or "effective" practice – please vote on the new slate of officers and the proposed by-laws changes. Jennifer Long, who will assume office as President in April, has prepared an excellent annual meeting program for April 20 in Birmingham. Registration and program information are included in this newsletter. Sign up and participate – we've missed you!



Proposed Changes to By-Laws

The executive board proposes the following changes to the by-laws. The proposed changes, noted in italics, will be voted on at the annual business meeting in April.

ARTICLE VI - Officers Section 1. Officers

The officers shall be a President, a Vice-President/President-Elect, a Past President, a Secretary, a Treasurer, a Member-at-Large, [and] a Newsletter Editor, a Legislative Liaison, and a Webmaster. Officers shall be professional librarians, members of the chapter, and members of ACRL.

Section 2. Terms of Office

- The Newsletter Editor, Legislative Liaison, and Webmaster will be recommended by the President, appointed by the Board, and will serve a renewable two-year term.
- (h) The Legislative Liaison shall monitor, on behalf of the Association, legislative issues relevant to academic and research libraries. In addition he/she shall respond on behalf of the Association to those issues. The legislative Liaison shall represent the chapter or recommend to the Board another member to represent the Chapter at appropriate meetings, forums, and events.
- (i) The Webmaster shall design and maintain the Chapter website.

Treasurer's Report

Legislative Report

In December and upon consulting with the AACRL Board, I sent to state representative Gerald Allen a letter on behalf of AACRL concerning his much-publicized pre-filed bill on the issue of homosexuality and its treatment in textbooks and library resources in the state of Alabama. Rep. Allen's bill, if it were to become law, would ban textbooks and library resources that "recognize or promote homosexuality as an acceptable lifestyle."

In the letter I expressed concern and opposition based upon the principles of intellectual and academic freedom. Below is the text of the letter:

Dear Rep. Allen:


I am writing on behalf of the Alabama chapter of the Association of College and Research Libraries (AACRL) in reference to your pre-filed bill that would ban textbooks and library resources that "recognize or promote homosexuality as an acceptable lifestyle." The Association of College and Research Libraries is a division of the American Library Association, founded in Philadelphia in 1876, the year of our country's centennial, and is the largest library association in the world.

While your bill is only in the pre-file stage, there has already been much discussion about it within our profession, certainly on the state level, but also outside Alabama. Your bill is causing great concern among librarians because of the threat it poses to the basic tenets of intellectual freedom. From an educational standpoint, if passed, it would also put at risk academic freedom in the classroom and due to this, quite possibly risk within Alabama accreditation by the Southern Association of Colleges and Schools for our state's colleges and universities.

You have been quoted as stating that your reason for taking this initiative is to protect children. I believe we can all agree that there are some things in our world about which children during their impressionable

years are to be guided with a protective hand: however, we believe that what a child reads or is exposed to through the arts is most appropriately and effectively monitored by the child's parents or guardians. Government in such cases must tread with extreme care or otherwise risk threatening the very freedoms we celebrate in this country. Because we live in a Western democracy, we must all at times contend with speech or visual images with which we disagree, perhaps at times vehemently. To do otherwise, to try and stifle that other individual's freedom may ultimately place our own at risk. It's a careful and at times difficult balancing act, but one that is so very important and one that makes us all proud to be citizens of the United States. Indeed, librarians routinely select for library collections items with which they hold personal disagreement, but we do so because we understand this greater good.

Beyond the philosophical, there are some very pragmatic reasons why this legislation would not be feasible in our state. I've already mentioned the potential risk to school accreditation. There is also the consideration that legitimate research sociological, psychological, legal, medical and even artistic - does occur in the area of human sexuality. Removing books or other materials that present any viewpoint other than negative on this issue from the libraries of our medical schools or from our law schools, or recognized works of great literature from any of the collections of our colleges and universities,



would certainly damage the educational potential of students in Alabama. Academic integrity would be greatly compromised and as our students look to pursue their education in programs outside Alabama, these students would be placed at a disadvantage, due to the perception that they are less well educated than their peers from other states.

Lastly, one must ask the question, "What next?". It's a very slippery slope down which we would begin. There have been many thinkers who during their time presented controversial views, at times at risk to their own lives, but whom today we look upon as giants in their fields; whose thoughts, ideas, creative works we have benefited greatly from and today we celebrate. It is difficult to judge at times what from our own time will constitute those seminal works for future generations, and this is one reason why librarians take the principles of intellectual freedom so much to heart.

Therefore, we find that we must express our opposition to the prefiled bill you have brought forth. We hope that you will give our concerns careful consideration and in the end come to agree that this would not be legislation conducive to a strong Alabama.

Copies of this letter were also sent to Rep. Seth Hammett, who serves as Speaker of the House, and to Rep. Demetrius C. Newton, who serves as Speaker Pro Tempore. I have not heard back from either of these gentlemen, nor from Rep. Allen. Alabama Library Association has also sent its formal objection to the bill, and quite undoubtedly individual librarians in the state have expressed their views to their representatives on this issue. While the likelihood is slim that this bill would actually go very far in the legislative process, it is still important for our profession to speak out on issues of intellectual freedom.


