## Boosinger Wins Award



AACRL revived its practice of recognizing outstanding contributions to academic librarianship by presenting the AACRL Significant Contribution Award to Marcia Boosinger at the annual dinner/business meeting in April 2005. The purpose of the award is to recognize the achievements and significant contributions in the area of college and research libraries on the local, state, regional, national, or international level.

Boosinger holds an MLS from the University of Alabama in addition to an MS in Library, Media, and Instructional Development from Purdue University. She is the Chair of the Reference Department at the Ralph Brown Draughon Library at Auburn University, where she has provided leadership in the library and around campus since 1984. Another significant part of her job at AU is to serve as the Faculty Athletic Representative and Chair of the Committee on Intercollegiate Athletics.

Boosinger has been particularly active in professional library associations and is a charter member of AACRL, serving as treasurer, board member and

as President in 2002-2003. She has served in various capacities in the Alabama Library Association (ALLA), from the Alabama Library Instruction Round Table to Convention Co-Chair to Handbook Committee to her current role on the Executive Council. At the national level, Boosinger presently serves as the ALA Chapter Councilor and is a member of the Academic/Eligibility Compliance Cabinet and Continuing Education Eligibility Committee.

She has also worked on the Chapter Relations Committee, Membership Committee, Coordinator of the LAMA Mentor Program, LITA Desktop Publishing Committee, and the New Members Round Table, to name a few of her committee assignments.

Boosinger has published several articles, including a number of reviews for the *Journal of Academic Librarianship*. She has been a frequent presenter at library conferences, notably in the field of library instruction. This is by no means a full list of her service to the profession; a complete resume has been added to the minutes of the AACRL Board to document Boosinger's record of achievement.

AACRL is not the only organization to honor Boosinger. She is the recipient of the Blackwell North America Award for Research Promise in Librarianship and a Graduate Research Council Fellowship with the University of Alabama. She is also a member of Beta Phi Mu (including charter membership in the Purdue chapter). AACRL made a good choice in Marcia Boosinger for the recipient of its 2005 "Significant Contribution Award."

# AACRL Represented at National Legislative Day

On May 3-4, 2005, I was present for National Legislative Day in Washington, D.C. While generally thought of as an ALA event, it is actually sponsored by ALA, the Special Libraries Association and the District of Columbia Library Association. I joined Jaunita Owes, director of the Montgomery City – County Public Library, and Rebecca Mitchell, director of the Alabama Public Library Service (accompanied by her husband Derick who presented a library user perspective), to form the Alabama delegation. We were a small group, certainly compared to some other states; however, we found that this worked in our favor as we each were able to attend all our meetings at congressional offices and have the opportunity to speak on legislative matters related to libraries. Primarily, I addressed those matters that most concerned academic and research libraries and Jaunita and Rebecca addressed those most pertaining to public and school libraries.

We were fortunate to have the opportunity, thanks to Rebecca's scheduling, to meet with all but one office, that of Sen. Jeff Sessions. It is quite the norm that on such visits one meets exclusively with congressional staffers, which is fine since these are the men and women whom representatives and senators rely heavily upon when making policy decisions. We were again fortunate in that during our visits this day we had the opportunity to meet and sit briefly with several of Alabama's U.S. Representatives: Robert Aderholt, Mike Rogers and Spencer Bachus.

Legislative Day began with a full briefing day on May 3 led by members of ALA's Washington Office and others. Topics covered included copyright, E-rate, the Patriot Act, and legislation concerning the preservation and dissemination of government information. There were also concurrent sessions in the after-

noon to help prepare delegates for meeting with their congressional representatives (and/or staffers) and making the most of the short period of time that would be spent in each office. On this day AACRL sponsored a luncheon for academic librarians who were attending Legislative Day (approximately 45 attended this luncheon) where Stephanie Vance of AdVAnCED Consulting spoke. Vance is the author of *Government by the People: How to Communicate with Congress*, and is herself a former congressional legislative aide.

Day two of Leg Day was spent visiting Capitol Hill. There is a reason they call it Capitol Hill, and one soon discovers this reason after a day of traversing it, going from building to building, office to office in not so sensible shoes. If you've never had the experience of visiting congressional offices, you may be surprised to learn that the majority of staffers are in their twenties (Vance in her presentation at the AACRL luncheon referenced this using a personal experience, when in her early thirties she was looked upon as the experienced elder of her office). Staffers (or Legislative Assistants or Aides) have specific areas assigned to them and primarily we met with those who were the education liaisons for their elected member of Congress.

As I mentioned earlier, for our Alabama visits each of us in our delegation focused upon one or two pieces of current legislation, knowing our time per office visit was only fifteen to twenty minutes.

Jaunita and Rebecca talked about E-rate, increased LSTA funding (\$221.3 million as proposed by the president) and the \$100 million funding proposed for the Improving Literacy Through School Libraries, which would allow more effective implementation of the No Child Left Behind Act as it would provide school libraries with the necessary funding to purchase the required

materials to support the classroom literacy initiative.

I spoke on behalf of H.R. 1201 and H.R. 1157. H.R. 1201 is a fair use bill called the Digital Media Consumers Rights Act of 2005, which among other things would allow libraries to circumvent access control mechanisms imbedded in DVDs and CD-ROMs for the purposes of preservation and archives, and is a response to the Digital Millennium Copyright Act of 1998. H.R. 1157 is the Freedom to Read Protection Act and would amend the USA Patriot Act. If passed it would reinstate certain pre-Patriot Act standards the FBI must meet to obtain FISA (Foreign Intelligence Security Act) court orders and warrants for gaining access to library and bookstore user records.

We covered many of the same legislative topics when meeting with Goodloe Sutton of Sen. Shelby's office and were very pleased to find much common ground. I specifically addressed continuing concerns with Section 215 of the Patriot Act and spoke on behalf of passage of S. 317 – the Library, Bookseller, and Personal Privacy Act. Additional senate bills mentioned were S. 622 – the "Restore FOIA" Act, S. 392 – "Openness Promotes Effectiveness in our National Government" Act of 2005, and S. 589 "Faster FOIA" Act of 2005. What is found when looking at many of these pieces of legislation is that there is bi-partisan support for them – certainly a factor that should strengthen the message.

Attending Legislative Day is a very worthwhile experience and I would encourage anyone with even a remote interest in legislative matters to attend. Certainly there are the additional security measures one must tolerate flying in and out of Washington as well as gaining access to the buildings of Capitol Hill and many of the museums and other points of interest, but the opportunity

to sit down with your members of Congress or their staff truly does make one feel a part of the democratic process. It is very easy to become cynical of the wheels of government. What I found was that those we met with gave us their attention and appeared to truly listen to our concerns.

One recommendation I brought back to our AACRL Board was an idea I shared with Mary Ellen Davis, executive director of ACRL, at the Legislative Day wrap-up session: I would like to see states consider including a student as part of their delegation.

Specifically, I think an undergraduate student, who could speak on behalf of users of school, public and academic libraries; could make a unique impression on our elected officials and their staffs. Mary Ellen Davis was supportive of the concept and suggested starting with a pilot project. Our AACRL Board has given support to pursue this to see if we can identify a student who could attend the 2006 Leg Day and what funding would be available to assist with the costs. I will be contacting some of our other library organizations in Alabama to further discuss this idea.

## AACRL Chapters Council Report

The ACRL Chapters Council met on Sunday, June 26, 2005, during the American Library Association Annual Conference in Chicago. Elections were held for the officer positions of Vice-Chair and Secretary. The Chapters Council officers for 2005/2006 are: Chair, Mark Emmons, University of New Mexico; Vice-Chair, Nora Quinlan, Nova Southeastern University; Past-Chair, Vibiana Bowman, Rutgers University; Secretary, Ann Watson, Denison University; and Editor of Chapter Topics, Doreen Kopycinski, Ursinus College.

The meeting began with an overview of the ACRL Chapters Council. The council is composed of the President and Vice-President of each ACRL chapter or a delegate who is a member of the executive board. Its mission is to serve as the central means of communication among the chapters and between the chapters and ACRL. Its goals are to provide a forum for the exchange of information and ideas, promote the organization and development of chapters, offer orientation and support for chapter officers, and forward chapter concerns and needs to the ACRL Board. The mission and goals are achieved through meetings at the

ALA Midwinter and Annual Conferences, the *Chapter Topics* newsletter, and the electronic mailing list.

Following the overview of the Chapters Council, there was a discussion about the relationship between ACRL and its forty-two chapters. ACRL is a national organization responsible for fostering the profession of academic/research librarianship, and its chapters are separate organizations with an interest in academic/research librarianship that request affiliation. ACRL chapters are responsible for supporting the goals and initiatives of ACRL, providing a local presence for ACRL, building membership in ACRL at the national and local levels, and promoting excellence in academic and research libraries through programming and professional development opportunities and legislative advocacy. To support its chapters, ACRL provides funding for ACRL officers to travel and speak at chapter meetings and gives chapters \$1.00 for each ACRL personal member living in the geographic region. The meeting concluded with brief reports from several ACRL officers.
