Are you interested in being more involved in AACRL? Consider running for an office.



#### **Best Practices Sessions at ALLA**

AACRL, in association with CUS, will sponsor four Best Practices sessions at the ALLA convention in Mobile. The response to the call for proposals was excellent. Following are the topics that will be presented:

**Sterling Joseph Coleman, Jr.**; Digital Resources Librarian; Auburn University; Ralph B. Draughon Library "The Importance of Establishing Best Practices For Metadata In Digital Projects"

A description of the best practices that the Cornerstone Metadata Standards Working Group (CMSWG) adopted to develop metadata for the Cornerstone Project as well as the decision-making process that was used to reach these best practices. It will also explore the need and importance of establishing best practices for metadata in terms of selecting controlled vocabularies, creating a metadata work-form and providing documentation for the proper usage of the Cornerstone Metadata Work-form by participating institutions.

# News from the Membership

**Dr. Bob Schrimsher**, Pharmacy Librarian and Assistant Professor of Pharmacy Practice, McWhorter School of Pharmacy, Samford University, has been appointed as the editor of a new pharmacy journal, *The International Journal of Pharmacy Education*. Dr. Schrimsher, who proposed, planned, and implemented the journal, will also serve as the journal's technical editor.

The journal will be a scholarly, peer-reviewed, and Internet only journal. The address for the journal is http://www.samford.edu/schools/ pharmacy/ijpe/index.htm. There will be no subscription fee or password associated with accessing the journal. The journal became official in September and several articles have already been submitted for peer-review. The journal is soliciting submissions from both the national and international pharmacy community and has a broad focus: clinical pharmacy, pharmaceutical sciences, drug information, pharmacy education issues, international pharmacy, editorials, commentaries, and student papers.

The International Journal of Pharmacy Education has an excellent editorial board with members from the United States, Korea, Wales and the Netherlands. As articles are reviewed and approved, they will be published in the journal. It is anticipated that only four issues a year will be published.

**Jaroslaw Szurek** has accepted the position of Music Librarian at Samford University to begin January 2003. He holds a Master of Arts in Musicology and a Certificate in Information Science from Jagiellonian University in Krakow, Poland. Jaro is currently completing his Masters of Science in Information Science at the State University of New York, Albany, where he works in the Film and Television Documentation Center. He was the Music Librarian and Cataloger at the Institute of Musicology, Jagiellonian University.

The **University of Alabama** Libraries inaugurated a Reference Chat service on September 9, 2002. A member of the QuestionPoint Global Reference Network, the University Libraries are using the QuestionPoint chat program. # Stipend for National Library Legislative Day


