NIH Open Access Mandate Dominates Legislative Report

Perhaps the biggest, most recent federal legislative news that impacts academic and research libraries is the announcement that Congress had passed a bill that would require research conducted through NIH funding to be deposited into the PubMed Central database.

The bill further stipulates that such research would be available within a year of publication. Thus legislation has faced opposition from publishers as well as the White House, where it was expected to receive a presidential veto. Indeed, ALA reported in mid-November, that President Bush had vetoed the Labor, Health and Human Services (LSSA) domestic spending bill that included the new public access provision for research funded through the NIH.

ALA has reported that while the bill enjoyed wide support in both houses of Congress, it narrowly missed approval by the two-thirds that would be required to override the presidential veto, and believes such an override is unlikely to occur.

As reported in the Academic News-wire from *Library Journal* (November

15, 2007): "The veto means publishers opposed to the public access policy are likely to get one more shot to try to remove or amend the policy during negotiations. Although the bill was

States' longstanding leadership in upholding strong standards of protection for intellectual property.'

That mention suggests those opposed to the policy could have another, albeit remote, opportunity to revise or slash the policy. Supporters say that heavy bipartisan support for the policy suggest(s) it will survive intact, though advocates for the policy are urging supporters to contact their representatives. The NIH public access policy, strongly supported by libraries for years, would require researchers to deposit their final articles in the NIH's PubMed Central database to be made freely available within a year as a condition of grant funding."

It is important to note that the current policy provides for voluntary submission of NIH-funded research, rather than requiring it. As a result, it has been reported that only 5% of such research has indeed been submitted for public access.

Auburn University Montgomery has announced the retirement of **Betty Tims**. Sue also gave the same presentation for Southeast region virtual library directors at SOLINET's Virtual Library Summit in Atlanta.

She was graduated from Simmons with honors in May. Ellen is already teaching Freshman English library sessions, designing online tutorials, revamping the library's webpage and adjusting to life and weather in the Deep South.
