# **Proposed By-laws Revisions**

The purpose of the revisions proposed is to establish new membership categories in order to encourage library paraprofessionals and library/information science/archivists students to join and maintain membership in the Alabama Association of College and Research Libraries (AACRL).

#### Currently, Article V reads:

- (a) Eligibility for Membership: All current and retired librarians; library and information science faculty; library paraprofessionals, information specialists and archivists who are associated with college, university or research libraries; and library/information science/archivist students are eligible for membership in AACRL.
- (b) Term of Membership: The membership year shall be the calendar year.
- (c) Institutions: Membership is not open to institutions.

Section 2. Dues

- (a) Annual dues rates shall be set by the chapter at its annual meeting as required.
- (b) Annual dues shall be due and payable upon the first day of January.

Section 3. Maintenance and Loss of Good Standing

- (a) All members of the chapter shall remain in good standing as long as they shall be current in payment of dues.
- (b) Any member who shall not have paid current chapter dues on or before the first day of the year shall be automatically suspended from membership. Upon payment of chapter dues for the current year, membership shall be reinstated and the rights and privileges of membership restored.

Proposed change to Article V, Section 1(a): "Eligibility for Membership: All current and retired librarians, library and information science faculty, information specialists and archivists who are associated with college, university or research libraries (library/information professional category); library paraprofessionals/staff (paraprofessional category); and library/information science students and students interested in the information disciplines (student category) are eligible for membership in AACRL."

Proposed change to Article V, Section 2(a): "Annual dues rates for three membership categories (library/information professional, library paraprofessional/staff, and student) shall be set by the chapter at its annual meeting as required."

Should this proposed change to by-laws be ratified by the membership, an additional vote will be held to establish the dues levels for the different categories.

#### Proposal:

Dues for the library/information professional category remain at \$10/year.

Dues for library paraprofessionals/staff set at \$7/year.

Dues for students set at \$5/year.

# Legislative Report Declaration for the Right to Libraries

You may have heard about the new Declaration for the Right To Libraries that ALA is promoting. The Alabama Library Association Legislative Development Committee integrated a promotion of the Declaration into this year's (2014) state legislative day. The Declaration for the Right to Libraries is the cornerstone document of ALA President Barbara Stripling's presidential initiative, Libraries Change Lives, which is designed to build the public will and sustained support for America's right to libraries of all types – academic, special, school and public.

In the next year, libraries of all types will hold signing ceremonies, during which community members can visibly declare their right to have vibrant libraries in their community. The signing ceremony is intended to serve as the launching point for continued and vibrant community engagement to:

- Increase public and media awareness about the critical role of libraries in communities around the country
- *Inspire ongoing conversations about the role of the library in the community*
- Cultivate a network of community allies and advocates for the library
- Position the library as a trusted convener to help in the response to community issues

You can organize your own signing event at your library, and if you do, please let AACRL (ekidwell@huntingdon.edu) know about your event. The AACRL Government Relations Committee and the ALLA Legislative Development Committee worked closely on the 2014 Alabama Legislative Day.

# Federal Legislation

To learn about current federal legislation that ALA is asking membership involvement with, go to http://capwiz.com/ala/home/. Two pieces of legislation of concern are:

The Fair Access to Science and Technology Research (FASTR) Act, which addresses the issue of open access to federally funded research.

Innovative Approaches to Literacy (IAL) program to be included in the re-authorization of the Elementary and Secondary Education Act (ESEA). IAL funds a grant program for underserved school libraries. This program is important because school libraries, and the librarians who work in them, are the primary source in K-12 schools for reading, digital literacy training and the related education needed for students to gain the skills to function in careers and higher education in the digital age.
