Legislative Update

With a new Congress (and all the attention being given to investigations surrounding the current Administration), there isn't much at this time to report regarding library legislative issues. I'm sure more will develop later in the legislative year. So, at this time, we'll just remind everyone about changes in this year's National Library Legislative Day (NLLD), which is typically held in May.

Due to the 2019 ALA Annual Conference being held in Washington, D.C., ALA has decided to not hold a stand-alone NLLD in May. Instead, library advocacy will be folded into Annual Conference. As reported in the AACRL winter newsletter, here is how ALA is approaching the matter as reported out by Megan Ortegon of the ALA Washington Office:

In light of Annual Conference being held in DC this June, we will not hold NLLD in 2019. We are currently planning advocacy activities as a part of the regular Annual programming, but we will not be having any ALA coordinated Hill visits during the 2019 conference. We will resume our traditional NLLD in 2020.

Given this year's schedule, we encourage advocates in your state to develop relationships with members of Congress at home. Below are a few ideas on how to engage your elected officials in your districts:

- *Schedule an in-district meeting with the member and their staff. Share your library's plans for the year*
- *Reach out to your local paper or blog and ask them to write a story about how your library is funded and how federal dollars support your branches*
- *Attend your member's town hall meetings*
- *Host a district event*

More information will be shared through AACRL communication channels as it becomes available.

For the last Treasurer's Report, the checking account balance was \$3,521.86 and the PayPal account was \$158.87. Since then, I received twenty-six AACRL membership renewals and six new AACRL memberships from PayPal for a total of \$730.16. Four checks for membership renewals and two checks for new memberships were received and deposited into the AACRL checking account in the amount of \$147.00.

\$700.00 was transferred from the PayPal account into the checking account. We received and deposited the \$137.00 check from ALA for the AACRL Chapter Reimbursement.


The AACRL Tax Exempt Status was renewed on 2/22/2019.

Vice-President / President-Elect



Dusty Folds, Jefferson State Community College
